Understanding Self-Regulation in Nursing

The Regulated Health Professions Act (RHPA, 1994) has been in the making since 1982, when the Health Professions Legislation Review Committee was formed. First Reading of the RHPA was given to the Ontario Legislature on April 2, 1991 by then Health Minister Evelyn Gigantes. A similar Act was introduced in 1990 by then Health Minister Elinor Caplan, but the subsequent provincial election stopped the "Regulated Health Professions Act" (RHPA, 1994) from proceeding.

Following first and second readings of the RHPA it was referred to the Standing Committee on Social Development for public hearings, clause-by-clause examination, and amendment. The College of Nurses of Ontario made two submissions to the Standing Committee on Social Development. The RHPA replaces eight pieces of legislation that govern eighteen professions. It replaced the Health Disciplines Act and became law December 31, 1993.
